Sculptra® Aesthetic (injectable poly-L-lactic acid) is an FDA-approved injectable treatment used to gradually restore lost facial volume and stimulate collagen production. It is used for facial rejuvenation, treating shallow to deep facial wrinkles, folds, and volume loss.

Sculptra works by stimulating the body's natural collagen production over time, with visible improvements occurring gradually over 4 to 12 weeks. Full correction typically requires a series of treatments (usually 2 to 3 sessions spaced 4–6 weeks apart).

Medical History – Please Inform Your Provider If You Have:				
	History of keloid or hypertrophic scars			
	Autoimmune diseases or immunosuppressive conditions			
	History of allergic reactions to any injectable products or lidocaine			
	Active infection, rash, or cold sores at or near the treatment site			
	A bleeding disorder or are currently taking blood thinners			
	Had recent or upcoming dental work including cleanings (within 4 weeks)			
	Are pregnant, breastfeeding, or trying to conceive			

Pre-Treatment Instructions

To minimize the risk of bruising and complications:

- Avoid aspirin, NSAIDs (e.g., ibuprofen, Advil), vitamin E, fish oil, and alcohol for 3–5 days before treatment
- Do not receive Sculptra within 4 weeks of dental work including cleanings, vaccinations, or other invasive procedures.
- Arrive with clean skin (no makeup or skincare products).
- Hydrate well in the days leading up to your appointment.

Post-Treatment Instructions

- Massage the treated area for 5 minutes, 5 times a day, for 5 days. This helps evenly distribute
 the product and reduce the risk of nodule formation.
 - o To reduce the risk of infection, always wash your hands and face prior to massaging.
- Avoid strenuous exercise, saunas, steam rooms, or excessive sun/heat exposure for 24-48 hours.
- You may experience swelling, redness, bruising, or tenderness at injection sites—this typically resolves within a few days.
- Keep the skin completely clean for 24 hours.
 - o Avoid all skincare products and makeup
 - o Avoid touching face with phones and animals
 - Use clean pillowcases
- Results will develop gradually over weeks to months. A follow-up evaluation and possible additional treatments will be discussed.

Risks and Side Effects

Although rare, possible side effects and complications include:

- Redness, tenderness, bruising, swelling
- Itching or discomfort at injection site

- Formation of small lumps or nodules under the skin
- Asymmetry or uneven correction
- Granuloma formation (inflammatory response)
